  - Herastrau Park –Victoriei Square (*P-ta Presei Libere – Kiseleff Blvd –Lasca Catargiu Blvd –Romana Square*),
  - Muncii Square –I.O.R. Park (*Basarabia Blvd –Nicolae Grigorescu Blvd*),
  - Politehnica – Splaiul Independentei (*Iuliu Maniu Blvd – Cotroceni*),
  - Operei Square – Universitate (*Splaiul Independentei –Kogalniceanu Square –Regina Elisabeta Blvd*),
  - Operei Square –Unirii Square (*Splaiul Independentei*),
  - I.O.R. Park (*Campia Libertatii –Baba Novac Blvd–C-tin Brancusi Str –Liviu Rebreanu Blvd– Nicolae Grigorescu Blvd*),
  - Titan Park (*Liviu Rebreanu Blvd – N. Grigorescu Blvd – Camil Ressu Blvd*).
